Launched in 2011, ACGS serves as a benchmarking tool aligned with internationally recognised standards, particularly the G20/OECD Principles of Corporate Governance, to raise governance standards and improve transparency while fostering investor confidence across ASEAN.

The ACGS assessment involves six ASEAN countries, namely Indonesia, Malaysia, the Philippines, Singapore, Thailand, and Vietnam. Assessments are conducted by independent Domestic Ranking Bodies appointed by each participating country.
